ELIGIBILITY: The Earn a Night With TPC Point of Purchase ("POP") Sweepstakes ("**Sweepstakes**") is open only to (i) eligible General Managers and Store Managers ("Entrants") who are: (i) employed and in good standing at an eligible participating HDI Direct or Love's store location ("Store") as of February 1, 2026 through the dates of the Sweepstakes Period (as defined below); (ii) legal residents and currently residing in the United States (excludes all U.S. territories and possessions) or the District of Columbia (collectively, the "US"); and (iii) at least eighteen (18) years of age as of February 1, 2026 (or the legal age of majority in their state of legal residence).
